Road Traffic Regulation Act 1984

Notice is hereby given that THE KENT COUNTY COUNCIL, acting as the local traffic authority and in exercise of their powers and under sections 1 and 2 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the said Act of 1984 intends to make the following Order:

The effect of the proposed named Order will introduce, amend or retain existing speed limits in Ivychurch, New Romney in the following lengths of road.

1. To retain the 30MPH Speed Limit in the following length of road

ASHFORD ROAD; from a point 116 metres northwest of its junction with Ivychurch Road to a point 480 metres southeast of that junction

2. To implement a 40mph speed limit in the following length of road

ASHFORD ROAD; from a point 480 metres southeast of its junction with Ivychurch Road to a point 880 metres southeast of that junction

3. To amend the Derestricted Speed Limit length in the following road

ASHFORD ROAD; from a point 880 metres southwest of its junction with Ivychurch Road to a point 90 metres northwest of its junction with Sussex Road

A copy of the proposed Order, statement of the Council's reasons for making the proposed Order, a map indicating the location and the effect and a copy of any other Orders which will be amended by the proposed Order may be examined on Mondays to Friday at The Kent County Council, Sessions House, Maidstone, ME14 1XQ and at The Kent County Council, Highway, Transportation & Waste, Ashford Highway Depot, Henwood Industrial Estate, Unit 4 Javelin Way, Ashford, Kent TN24 8AD during normal office hours.

REVOCAATION, MODIFICATION AND AMENDMENTS

The "Kent County Council (Various Roads, The District of Shepway) (20MPH, 30MPH, 40MPH, 50MPH Speed Limits and Derestricted Roads) Consolidation Order 2012" ("the Order of 2012") be amended as follows

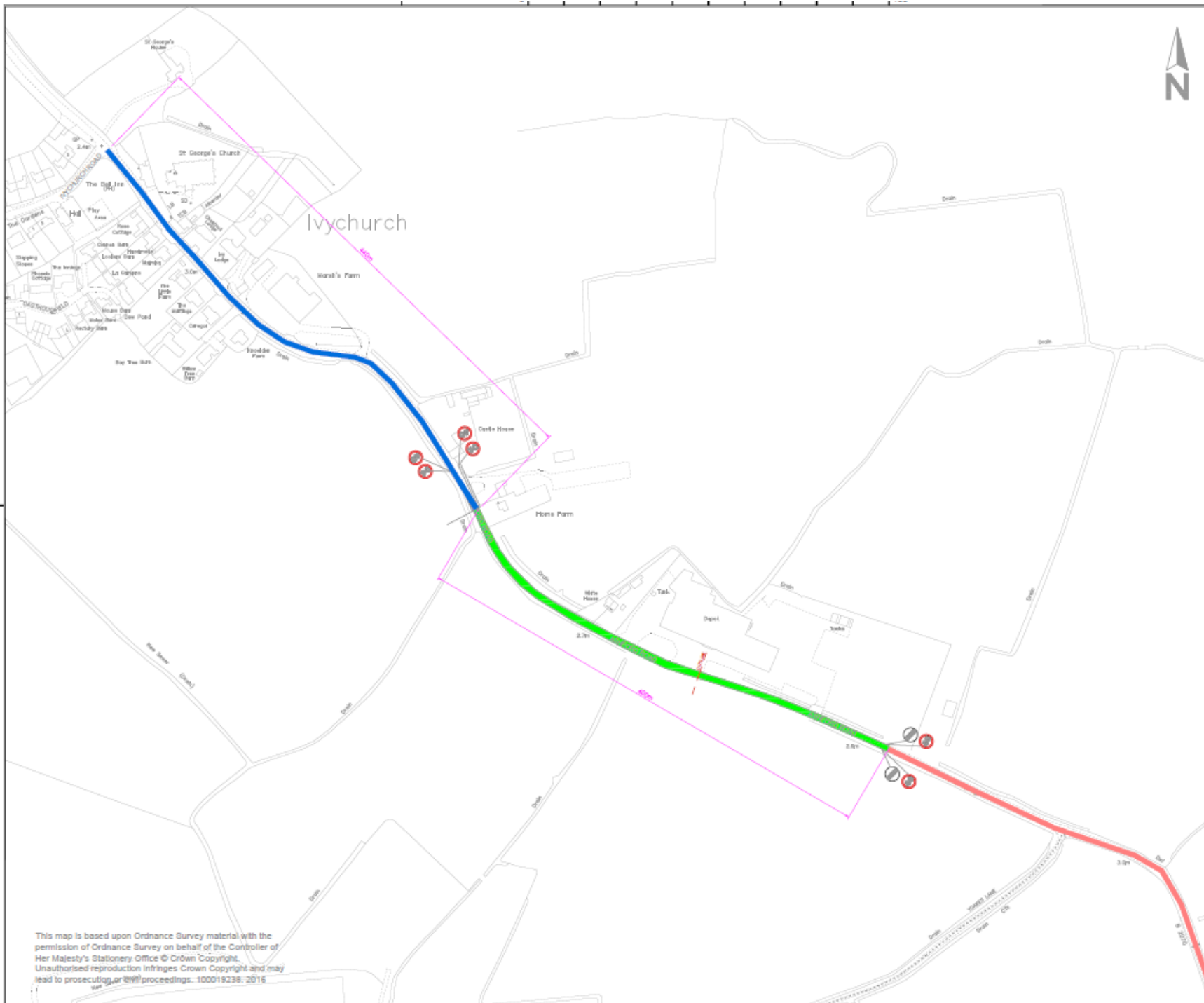
